# **Industry experience**

#### Central Bank of Sri Lanka

Central Bank of Sri Lanka is the monetary authority of Sri Lanka which has the responsibility for price stability and financial stability of the country. It also has the regulatory authority over Banks and other financial institutes, Payments systems service providers and Foreign exchange service providers.

Head of the Money and Banking Division, Economic Research Department (August 2006-August 2008)
Head of the Money and Banking Division is a non-voting member of the Monetary Policy
Committee that makes monetary policy decisions. The division collects and compiles all
monetary statistics, prepares the Monetary and Financial Program for the country and
ensures its implementation, conducts relevant research and makes initial suggestions on
monetary policy to be approved by the Monetary Policy Committee. I assumed the
responsibilities of this position at a time when the inflation was at a historical peak and
initiated stabilization policies including several ad hoc approaches.

Head of the Payment Systems Policy Division, Payments and Settlements Department (September 2003-September 2005)

I was responsible for the oversight of the country's payment system which included the Real Time Gross Settlement System, Sri Lanka Interbank Payments System (for small value retail payments), Check clearing systems and electronic card operations (credit, debit and pre-paid

cards). I also involved in drafting the Payments Systems Red Book published by the BIS and initiating a payments systems policy for the country. The Division was also responsible for collecting and compiling payments systems related data and publishing the quarterly Payments Bulletin.

Assistant Director, Payments and Settlements Department (February 2003-September 2003)

I joined the Bank to take lead in the implementation of a Real Time Gross Settlement System for settling setting large value interbank payments which went live in September 2003. My role involved coordinating between the software vendor (Logica, UK), communication service providers (SWIFT, Sri Lanka Telecom), other Departments of the Bank (IT, Finance), participants of the system (Commercial Banks and Securities Dealers); providing technical inputs to ensure smooth integration of the system with other existing systems and training the system operators.

#### Sri Lanka Telecom

Sri Lanka Telecom is the largest telecommunication services provider and the largest public quoted company in Sri Lanka with over 10,000 employees. In 2002, few years after deregulation, SLT still enjoyed a near monopoly in international voice communications but was facing a fierce competition both from other emerging service providers providing fixed band width services as well as from IP-based voice communication service providers.

Engineer – International Switching Center & Quality of Services Measurements Unit (August 2002-December 2003)

I was in charge of two separate units operated under the International Division. The International Switching Center was responsible for the swift maintenance of telecommunication switches used for international voice communications including 24x7 real-time monitoring, breakdown maintenance, modification of routings as required and expansions. The Quality of Services Measurements Unit was responsible for collecting and analyzing traffic data, identify bottlenecks and redundancies and suggesting route modifications so that the switching circuits are utilized in an optimal manner. During my tenure there, I developed a software application using Visual Basic and Microsoft Access to read traffic data directly from switches, analyze data and prepare required reports automatically.

#### Advanced Business Automation Systems (Pvt) Ltd

*Technical Director (January 1997-August 2002)* 

I joined ABAS as a freelance programmer in 1996 when the company was established and moved there to work fulltime in 1997. The company had only 5 fulltime employees at that time but grew faster to employ over 30 people (mostly engineers, technicians and software developers) by 2001. The company served a niche in the country and provided customized hardware integrated software solutions using a portfolio of software and hardware products including barcode products, biometric security products, surveillance systems, access control systems, time and attendance tracking systems, production monitoring systems, portable data collectors, digital display boards and plastic ID cards. Software was written using various programming languages including C++, Visual Basic, dBase, FoxPro and various machine languages for RS-232 communication. I was in charge of the technical and customer support

operations of the company. In 2001, I initiated expanding the operations of the company to Bangladesh but it was not a financial success.

### OpenArc Systems Management (Pvt) Ltd

Software Engineer (October 1995-December 1996)

OpenArc Systems Management is a software development company in Sri Lanka, specialized in software for Banking and Financial industries. In 1995, this company -then 4-years oldemployed over 50 software developers and was the market leader in providing software for stock broking firms in Sri Lanka and was investing in developing a comprehensive software application package for Investment Banks including separable modules for stock broking, leasing and hire purchase, Treasury bill management, margin trading, commercial credit etc. The application was developed using Progress 4GL one of the few graphics-based development tools available at that time and Progress RDBMS which was an open-architecture relational database. I started my carrier at the OpenArc as a team member of the Treasury bill module and later promoted as the Team Leader/Manager of the Stock Broking module. By the time I left OpenArc I was working as the Quality Assurance Manager overlooking all software modules.
